(Permits will not be processed without all the information below)

- 1) Copy of the operator's ATF License/Permit (Federal Bureau of Alcohol, Tobacco, Firearms and Explosives).
- 2) Copy of the operator's PGI Display Operator Certification or other formalized training certification.
- 3) Evidence of financial responsibility by the sponsor of the event and by the operator of the fireworks display by attaching a copy of the corporate security bond or public liability insurance policy; Bodily Injury: \$2,000,000 per person, Property Damage \$2,000,000 and Total Liability Coverage: \$4,000,000. Coverage shall include the entire period between the date the fireworks are delivered and the date the fireworks are displayed.
- 4) The approximate number and kinds/types of fireworks to be discharged.
- 5) List fireworks in sequential order that they will be discharged.
- 6) List of the fireworks display crew and their position(s); (operator/shooter, assistant, spotter, etc.) that will be on-site during the delivery, preparation, installation and display of the fireworks.
- 7) A letter stating ownership of the land from which the display will take place, with owner's release signature.
- 8) The manner and place of storage of such fireworks on the display site.
- 9) A diagram/site plan.

Site Plan Information

The Site Plan shall include:

- 1) The dimensions of the display site and locations of discharge site(s), spectator viewing area(s), parking area(s), fallout area(s), and associated separation distances.
- 2) Location and distances of all buildings including tents, highways, roadways, above ground pipelines, aboveground storage tanks, utilities and other possible overhead obstructions.
- 3) Location of onsite fireworks storage areas.
- 4) Likely wind direction.
- 5) Traffic plans indicating the flow of vehicles into and out of site before and after display.
- 6) Location of access and control points into the shoot areas.
- 7) Location of emergency vehicle staging area and access routes.

Fire Department Stand-by & Permit Fees

Fire Department shall be onsite before, during and after the fireworks display. The stand-by rate is \$100.00 per hour. One hour minimum is required then billed in 15 minutes increments beyond the first hour. This fee is additional to the permit fee and will be billed. Permit fee shall be paid before the permit is issued.
